# THE SCHEDULE OF APPROVAL

#### 1. PRODUCT DESCRIPTION:

## Isover TapeLock 7300/Isover Climpipe Section Alu2

Non-combustible glass wool insulation pipe sections with density of 75 kg/m<sup>3</sup> faced with aluminium foil (85 g/m<sup>2</sup>).

The aluminium foil makes a longitudinal overlap with adhesive.

Nominal insulation thickness range is 20-120 mm and the outer diameter range 15-273 mm.

#### 3. TEST REPORTS:

- 3.1 Glass wool+aluminium foil : test report N° PX22580, dated 26 March 2012, as per IMO FTP Code, Annex 1, Part 5 [testing standard : IMO Resolution A.653 (16)] from SP Technical Research Institute of Sweden.
- 3.2 Glass wool : test report N°6P00919 dated 31 March 2016, as per IMO 2010 FTP Code, Annex 1, Part 1 from SP Technical Research Institute of Sweden.

### 4. APPLICATION / LIMITATION:

- 4.1 In application of FTP Code 2010 Annex 2 § 2.2, the product is expected to satisfy the requirement of smoke & toxicity without further testing.
- 4.2 In application of FTP Code 2010 Annex 2 § 2.3, the product is expected to satisfy the requirement of maximum gross calorific value (e.g.  $45 \text{ MJ/m}^2$ ) without further testing.
- 4.3 The fitting aboard to be according to Manufacturer's instructions.

## 5. PRODUCTION SURVEY REQUIREMENTS:

This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. To this end, the production-control phase module D "Production Quality Assurance" or E "Product Quality Assurance" or F "Product Verification" of Annex II of the Directive is to be complied with and controlled by a written inspection agreement with a Notified Body.

## 6. MARKING OF PRODUCT:
